MINUTES RS BOARD MEETING October 24, 2002

Call to Order

The called meeting of the North Carolina Board of Sanitarian Examiners was held on Thursday, October 24, 2002 at the Parker Lincoln Building, Conference Room 201, Raleigh, N. C. Dennis Salmen, Chairman, called the meeting to order at 10:10 a.m. Those in attendance were: Dennis Salmen, Terry Pierce, Linda Sewall, Mack Dendy, William E. Pierce, Dr. Trenton Davis, An Gilstrap, Nilla Sloop, Sheila Nichols and Camille Bishop.

<u>Web Site Presentation</u> - presented by Andre Pierce, Travis, Malcolm Blalock

A presentation was made on a draft of the NC State Board of Sanitarian's Home Page and the various topics it will contain, i.e. Directory, Board Members, Intern Registration, Renewal, Continuing Education, Forms, Meetings, Examination, What's New, Links and Contact Us. The Board discussed and reviewed the descriptions presented.

Next Steps: Andre Pierce will send Board Members the RS Board WEB Site address and how to access it. Board Members are to review the contents/descriptions and send any comments to Malcolm Blalock by November 7. Also, Board Members are to resubmit their biographical information in an outline that was recommended back to Malcolm Blalock by November 7. Mr. Blalock will follow up with Mr. Pierce regarding other information and his for the WEB site. Mr. Blalock commented that we hope to have the WEB site up and running by December 2002. The Board discussed the expenses for the WEB site. To date the Board has not received a bill from Andre Pierce. The Board had allowed up to \$1,000. The Board also discussed paying Malcolm Blalock a consultation fee. Dennis Salmen will follow up with Andre Pierce and Malcolm Blalock regarding expenses and maintenance fee for the WEB and report back

at next meeting.

Mr. Salmen asked Board Members if there were any conflicts of interest or potential conflicts of interest outside of what has already been disclosed in the annual Statement of Economic Interest form. There were no conflicts of interest stated by Board Members.

Financial Report for September 2002

Board Action: <u>A motion was made by Terry Pierce, seconded by Trenton Davis to approve the</u> September 2002 Financial Report. All votes affirmative.

<u>Chair's Report</u> – Dennis Salmen

- . Stan Herndon was contacted by Mr. Salmen to let him know that his RS status based on prior experience was denied.
- . Davin Madden completed the Environmental Health Public Health Law Course in October.
- . Mr. Salmen shared a list from Ms. Bishop on interns registered in 1999 who had not completed the Environmental Health Public Health Law Course. Ms. Bishop will verify the list with Richard Dideriksen and report back to the Board at the next meeting.
- . Mr. Salmen has not heard back from John Barkley regarding a template for Public Health Law.
- . Request from Jean Cobb, RS from Halifax County, who is on medical leave of absence made a written request to the Board as to what she should do regarding her continuing education requirements for 2003 Renewal. She needs another 2.5 credit hours for the remainder of 2002. She faxed Ms. Bishop the request and her doctor's note stating she had chronic asthma, etc. Dr. Trenton Davis offered to let Ms. Cobb view 2 video tapes at East Carolina if she is able to travel. Ms. Bishop to follow up with Ms. Cobb to see if she is able to travel to view the tapes. If not, Ms. Cobb will need to send more documentation from her doctor that she is not able to travel.

<u>Vice-Chair's Report</u> - Terry Pierce

Mr. Pierce discussed the **Open Meeting Law**. Mr. Pierce sent information on the law electronically to Board Members. The Board discussed . Our board meetings will need to be advertised. They can be posted on our WEB site and also posted at the Parker Lincoln Building in Raleigh. If the Board has a Conference Call, we will have to provide a location for participants (only to listen). The Parker Lincoln Building was suggested.

Secretary/Treasurer's Re port – Ann Gilstrap

Ms. Gilstrap stated that the Board needs better policies on reimbursement for travel and clarification on expenses for meals. It was suggested that a time limit be set when a Board Member can be reimbursed for staying overnight. The recommendation was that if a Board Member has to leave before 7:00 a.m. to get to a board meeting that the person can choose to stay the night before, and if you would return home after 8:00 p.m., you can choose to stay that night. Ms. Gilstrap will draft some policies and procedures for review at the next meeting.

Secretary to the Board – Camille Bishop

. Ms. Bishop reported that there are 26 exam participants for the October 25th exam. One participant broke his right hand and was requesting that he bring someone to write for him on the essay. Mr. Salmen and Ms. Bishop talked to the participant's supervisor. It was the recommendation by Mr. Salmen that we not allow another person to write for the essay. The intern will be allowed to take the essay test at a later date if he passes the NEHA exam. Ms. Bishop volunteered to administer the essay exam to the intern at a mutually agreed upon site. The intern could also record his response on tape if he/she is not able to write.
