RS BOARD MEETING MINUTES

October 5, 2006

Board Meeting

The meeting of the N.C. State Board of Sanitarian Examiners was held on Thursday, October 5, 2006 at the 2728 Capital Blvd Building in Raleigh. Called to Order – Malcolm Blalock, Chair called the meeting to order at 10:28 a.m.

<u>Conflict of Interest Statement</u> – Malcolm Blalock asked Board Members if there were any conflicts of interest or potential conflicts of interest since the last meeting. There were no conflicts of interest stated.

Approval of Minutes - Janice Jones

Minutes for the September 11, 2006 meeting were distributed. The following corrections were noted: Lynn Lathan was present at the meeting; add reason for closed session to discuss disciplinary matters.

Board Action: A motion was made by Terry Pierce and seconded by Mack Dendy to approve the Minutes as corrected. All votes affirmative.

Board Action: <u>Motion made by Terry Pierce and seconded by Mack Dendy to enter into Closed Session to discuss</u> Closed Session Minutes. All votes affirmative.

Board entered into Closed Session at 10:40 a.m. to discuss Closed Session Minutes.

Board reconvened in Open Session at 11:00 a.m.

Board Action: <u>Motion made by Layton Long and seconded by Mack Dendy to approve Closed Session Minutes with</u> corrections. All votes affirmative.

<u>Approval of the Financial Report – Janice Jones</u>

Janice Jones presented the Financial Reports. Bank Balances as of September 25, 2006 were checking account -\$7,001.48, Money Market account - \$8,816.16 and Share account - \$32.78. Total of these accounts are \$15,850.42.

<u>Chair's Report – Malcolm Blalock</u>

- Malcolm Blalock reported that he had corresponded with David Stone, Surry County Health Director, about the Environmental Health Technician position description. He reported that Mr. Stone would like to have some guidance from the Board to develop a job description. Ms. Gilstrap reported that Mr. Stone had been asked to attend the next Study Committee Meeting.
- Mr. Blalock reported that he made a presentation at the Environmental Health Law Course in Black Mountain pertaining to ethics on September 20th.
- Mr. Blalock met with Ann Gilstrap and Janice Jones to review the 120 page document from the Office of State
 Controller concerning Internal Controls Report. They completed the review and the self-assessment tool.
 Assignments were made for each Board member to work a portion of the Report to develop policies and procedures.
 Each Board member is to make a report at the next meeting. Mr. Blalock would like to have the final product completed by June 2007.
- Mr. Blalock reported that he had met with DEH and Blue Lizard representatives to discuss moving forward on the creation of the RS Credentialing and Training System.

<u>Vice-Chair's Report – Terry Pierce</u>

- Terry Pierce reported that his department would be funding the joint database development.
- Mr. Pierce presented a copy of a document from Office of State Personnel which lists the wrong requirements for an environmental health specialist. This brought up for discussion what the Board counts as "work experience" for an intern. After much discussion, the consensus was that the Board counts "work experience" as work performed as an Environmental Health Specialist.

Board Action: Motion made by Layton Long and seconded by Dr. Burt Ogle to not count work as a technician for the required work experience for RS registration. Terry Pierce abstained from voting. All other votes were affirmative.

<u>Secretary-Treasurer's Report – Ann Gilstrap</u>

<u>Administrative Secretary's Report – Janice Jones</u>

- Ms. Jones reported that there has been an increase in interns in the past year compared to previous years. There has been an increase in other aspects of the workload.
