RS BOARD MEETING MINUTES

September 22, 2009

Board Meeting

The meeting of the NC State Board of Sanitarian Examiners was held on Tuesday, September 22, 2009 at the Carteret County Health Department in Morehead City NC. Those in attendance were: Ann Gilstrap, Malcolm Blalock, Patricia Hawkins, Terry Pierce, Sheila Nichols, Perry Solice, Layton Long and Janice Jones. Dr Burt Ogle and Lynn Lathan were absent

Called to Order – Chair Ann Gilstrap called the meeting to order at 10:21 a.m.

<u>Conflict of Interest Statement</u> – Chair Ann Gilstrap asked if any Board Member wishes to speak to the appearance of any actual or potential conflicts of interest. There were none stated. Ms. Gilstrap reminded Board members to recuse themselves when action on a staff member, family, or friend is under consideration by the Board. She also reminded Board members that they should refrain from participation in any discussions in which they may have a potential or existing conflict of interest.

After some discussion, it was determined that a policy needed to be developed to have another Education Committee Member besides Dr Ogle to review the transcripts from WCU to assure no conflict of interest exists for those applicants.

Approval of Minutes - Janice Jones

Minutes for the June 25, 2009 meeting were sent to all Board Members. Janice Jones informed the Board that one name on the Approved List for RS status was no longer employed and the Minutes needed to be amended to remove it from the list.

Board Action: Malcolm Blalock made a motion to approve the Minutes as amended. Motion was seconded by Perry Solice. All votes affirmative.

Closed Session minutes were mailed to all Board Members.

Board Action: Malcolm Blalock made a motion to approve the Closed Session Minutes. Motion was seconded by Terry Pierce. All votes affirmative.

Financial Report – Janice Jones

Janice Jones presented the Financial Report. Bank Balances as of September 18, 2009 were Checking account - \$200.73, Money Market account - \$7,022.80, Share account - \$34.46 and STIF account - \$25,512.80. Total of these accounts are \$32,770.79.

Board Action: <u>Terry Pierce made a motion to accept the Financial Report. Motion was seconded by Patricia Hawkins.</u> All votes affirmative.

Malcolm Blalock, Secretary-Treasurer presented and explained a Budget/Expense Report. He asked the Board for permission to purchase another copy of QuickBooks so that the Secretary-Treasurer could keep more up to date with spending and budget matters.

Board Action: <u>Terry Pierce made a motion to approve the purchase of a copy of QuickBooks software for the Secretary-Treasurer.</u> <u>Motion was seconded by Perry Solice.</u> <u>All votes affirmative.</u>

Chair's Report - Ann Gilstrap

Chair Gilstrap reported that training of Board members is now required within 6 months of appointment and every two years thereafter. This will increase the costs of the Board. It was suggested that the training could be held as part of a Board meeting if possible.

Legislative Oversight Committee will be looking harder at Boards to assure that they meet certain timelines.

Name change is now in effect. The correct acronym is REHSI and REHS. New Board name needs to be updated on the Department of Commerce website.

Notification of exam results was discussed and the need for a policy. RSTAS will be fixed to show pass/fail and date of eligibility. The exact scores will be accessible by the individual when logging on to RSTAS. Administrative Assistant will send an email to inform the applicants that scores are available on RSTAS and individual letters will not be sent.

Course monitoring by Board members was revisited and after lots of discussion, no consensus as to what to do was reached.

Attorney John Barkley is now present via telephone at 11:40 a.m.

John Barkley will investigate the possibility of providing training for several boards to see if it is feasible for the AG's office to provide.

Board Action: <u>Malcolm Blalock made a motion and seconded by Terry Pierce to enter into Closed Session to discuss investigations</u>. All votes affirmative.

Board went into Closed Session at 11:54 a.m.

Board is now in Open Session at 12:19 p.m.

During Closed Session, updates of investigations in Mecklenburg County and Albemarle Regional Health Services were discussed.

Public Health Law Course must be completed within four years of date of employment. Chair will consult with John Barkley on someone who is scheduled to take the course in September after their four years has passed.

Vice Chair's Report - Terry Pierce

Terry Pierce briefly discussed Blue Lizard and the database. CIT attendance numbers are down. Each module will have to be offered at least once a year. UNC will limit its SOP training to the Piedmont, instead of across the state. DEH is considering picking up some of the training. UNC will not be providing On-site training.

<u>Secretary-Treasurer's Report - Malcolm Blalock</u>

Malcolm Blalock reported that online payment has been investigated and it seems to be too expensive at this time. He suggested that it be reviewed for next year. Work is being done to reflect the name change of the Board on the website and in RSTAS. Redrafting of the Rules was also discussed.

<u>Administrative Assistant's Report – Janice Jones</u>

Janice Jones reported that the letterhead had been changed to the new name of the Board. She will take care of ordering new certificates, cards and an embosser.
