Board Action: <u>The Board approved the recommendation from the Education Committee to approve the</u> <u>above referenced 2012 Continuing Education requests with the exception of those noted as changed,</u> <u>pending or denied until further notice.</u>

Legislative Committee Report – Jeff French

House Bill 799 – Jeff and Seth have received request from Governor's Office asking how this bill would impact the REHS Board. In essence, the Bill would require licensing boards in the state to grant experience credit for active military (and spouses). Seth Swift stated that this Bill will not supersede reciprocity requirements, and all applicants would be required to meet REHS regulations and policies. Active military and their spouse could choose to apply for fast tracking if they meet the requirements of that process. It was agreed that HB 799 likely would not have significant impact on registrations and future reciprocity. Jeff French to respond to the Governor's Office regarding this matter.

Senate Bill 433 & House Bill 438 – Both bills address restructuring of some active Boards. At this time, neither bill speaks to the REHS Board.

State budget is scheduled for released today, and there are many unknowns at this point.

RSTAS Update - Seth Swift

The transition of RSTAS from Blue Lizard to the DHHS server continues.

Request for Public Records

The Board has received a public records request from Fred Smith, former REHS.
